QUESTION		COMMENT
Q 1:	Do you consider we have correctly identified the policy priorities for FY2010?	Contact agrees that Pipeline Balancing and compliance with gas governance arrangements should be a high priority area for the 2010 year. We also believe that Interconnect issues are of importance. Contact would like more emphasis placed on the determination of code change requests. Code change requests should provide an efficient means of achieving incremental improvement.
Q2:	Do you agree that it is necessary for the FY2010 annual levy to fund the roles under the approved gas governance arrangements?	Contact agrees that the levy should fund the roles outlined in the paper for compliance with gas governance arrangements. To not do so would devalue the work put into these arrangements.
Q3:	Do you agree we need to review the effectiveness of rule changes and make changes to those rules where appropriate?	The review of the effectiveness of the new arrangements is an important part of developing the gas industry given that most of these arrangements are at the immature/early lifecycle stage.
Q4:	Do you agree the industry facilitative roles are valuable and that it is appropriate to budget for, and use, levy funds in this manner?	Contact believes that the GIC does have an important role in the facilitation and development of the gas industry. Without the GIC's facilitation many issues that have arisen would still be unresolved. There will always be a tension between consultation, timely decisions, costs, benefits, individual party drivers and industry drivers. With its knowledge of the gas industry and interest in the overall health of the gas industry the GIC should be able play an effective facilitation role.
Q5:	Do you support the annual levy funding requirement for FY2010?	Contact supports the annual levy funding requirement and appreciates the efforts the GIC has made to reassess costs and workload commitments.
Q6:	Do you support the proposed annual levy for FY2010?	Yes, as per the above.
