#### Background:

A. On 1 August 2009, Jade notified the Market Administrator of alleged breaches (contained in breach notice 2009-114) of Rules 69.1, 69.2 and 78.1 of the Gas (Switching Arrangements) Rules 2008 (the "Switching Rules") by E-Gas, namely that E-Gas was not complying with various timeframes prescribed by the Switching Rules.

- B. The Market Administrator referred 2009-114 to an investigator, Jacquie Kean, for investigation, on 14 September 2009. The investigator extended the time for investigation to 24 November 2009.
- C. As a result of the investigation, the following emerged (in summary):
  - E-Gas admits that is was in breach of Rule 69.2 as alleged in respect of S-EGAS-07019, 07021 and 07022, and S-EGLT-07013, 07022, 07029 and 07030;
  - b. None of the other parties to the switches that are the subject of this record of partial settlement have joined as parties to breach notice 2009-114, so it may be assumed that any market impact of E-Gas's breaches was not material.
- D. The parties have agreed to resolve the above-listed seven of the 30 alleged breaches in 2009-114 as set out in this record of partial settlement.
- E. The following 23 alleged breaches (of Rules 69.1, 69.2 and 78.1) have not been settled and are not part of this partial settlement:
  - Alleged breaches to which Nova is a party: S-EGAS-07010, 07012, 07020 and 07024, and S-EGLT-07001, 07003, 07007, 07009, 07014 to 07018, and 07023 to 07028;
  - Alleged breaches to which Akld Gas is a party: S-EGAS-07004 and 07006, and S-EGLT-07033 and 07037.

#### Settlement:

- 1) It has been agreed that the breaches outlined in paragraph C (a) above should not be referred to the Rulings Panel for determination, for the following reasons:
  - a) E-Gas has taken steps to ensure compliance with the timeframes in the Switching Rules from 22 July 2009 onwards, namely a Chief Executive-driven undertaking (of that date) to comply with those timeframes, and the provision of one-on-one training for its staff on the regulatory requirements;

- b) The switches that are the subject of this partial settlement have been resolved.
- 2) This partial settlement of breach notice 2009-114 is subject to the approval of the Rulings Panel pursuant to regulation 34 of the Gas Governance (Compliance) Regulations 2008. If the Rulings Panel approves this settlement, this settlement will be final and binding on the parties to the breaches outlined above in paragraph C(a) and contained in 2009-114, on all participants, and on the Rulings Panel.

### Acceptance of parties to settlement:

- Jade notified its acceptance of the terms of settlement in writing to the investigator on 14 November 2009;
- The E-Gas companies notified their acceptance of the terms of settlement in writing to the investigator on 19 November 2009.
