Your views: Monthly read requirements for allocation group 4 meters

We are seeking your views on whether monthly read requirements are still fit for purpose for allocation group 4 (AG4) customers. These are customers with non-time-of-use meters that use from 250GJ to 10TJ of gas per year.

The Reconciliation Code, the industry agreement which preceded the Gas (Downstream Reconciliation) Rules 2008, had a more stringent requirement that AG4 sites must be read at or close to the end of the month. Monthly-read obligations have therefore been the industry norm for well over 20 years.

Our paper explains the rationale for consulting on this rule, proposes some options, and seeks your views to inform our decision on whether to keep monthly read requirements or amend them.

The consultation opens Thursday 9 May 2024 and will run for five weeks.

Interim gas quality standard enables biomethane

Standards New Zealand has published the interim NZS5442 gas quality standard allowing biomethane injection into the reticulated gas network.

The final version of this standard is expected to also allow blending of hydrogen gas within the network.

By specifying limits for contaminants, the standard seeks to ensure the integrity of the transportation systems and prevent operating problems for end users.

It has updated the test methods and frequencies, and the revised standard has also relaxed the limit for oxygen and water.

We would like to take this opportunity to thank the industry for their time and technical support in developing the interim standard and their ongoing involvement in the development of the final standard.
