## CONSULTATION REMINDER: Gas Industry Co FY2021 Work Programme and Levy

In December 2019, we issued our Consultation Paper: Consultation on Gas Industry Co FY2021 Work Programme and Levy. The Consultation Paper is in respect of our proposed work programme and levy for FY2021. This is a reminder that submissions are invited by **5.00pm, Monday 10 February 2020**.

## December 2019 switching numbers available

The Gas Registry statistics recording gas consumer switching numbers for December 2019 are available <a href="here">here</a>. There were 3773 completed customer switches during the month, 232 more than November 2019, and 201 fewer than December 2018.

For the last couple of years switching numbers and the time they take to complete has been relatively stable. In the last 12 months we saw, on average, 3,712 switches taking place per month, and they took an average of two days to complete. During that time the highest number of switches occurred in July 2019 (4,409) and the lowest occurred in January 2019 (3,217).

## Gas Industry Co appoints new Independent Director
