Extending the Electricity Price Review's Final Recommendations to the Gas Market – Submissions Analysis and Recommendations

In April 2018, the Government appointed an advisory panel to investigate whether the current electricity market delivers "efficient, fair and equitable prices" to customers. The Electricity Price Review panel issued its final report in May 2019.

The electricity markets have similarities and links to the natural gas and LPG markets, so Gas Industry Company thought it prudent to consider extending the Electricity Price review recommendations to the gas market as part of its policy objective of ensuring that gas is delivered to existing and new customers in a safe, efficient, fair, reliable and environmentally sustainable manner.

We established a workstream to investigate applying each of the Electricity Price Review recommendations. A consultation <u>paper</u> was published on 6 November 2020. 15 <u>submissions</u> were received. Gas Industry Company has now reviewed these submissions and developed a set of recommended next steps. These recommendations are set out in this paper.

Gas Market Settings Investigation

As announced in our last Bulletin, the Minister of Energy and Resources has asked Gas Industry Company to investigate whether current market, commercial and regulatory settings that provide for gas availability and flexibility are fit for purpose in supporting New Zealand's transition to a future with 100% renewable electricity from 2030 and a net zero carbon economy by 2050.

Gas Industry Company's investigation of the issues is underway. In March, we will meet with stakeholders to gather perspectives about current settings and where any issues exist or may develop.

Alongside our conversations, analysis is being undertaken of the gas supply and demand outlook under a variety of system scenarios.

In April, we plan to release a consultation document and seek input from stakeholders and interested parties. Depending on the outcomes of that consultation, further discussions and investigation may be required —we'll keep you posted.

When we report back to the Minister, we intend to set out current arrangements and issues, identify any potential issues and propose a work programme to address any issues identified.

Our timetable for completion is mid-2021.

Increasing rate of customer switching

3,921 customers completed switches during February 2021.

Customer switches were up by 503 from January, and up 314 from February last year.

Switching Trends

On average, 3,887 customers switched each month over the past year.

Switches took an average of two days to complete.

The highest number of customers switched in July 2020:

4,962. The fewest switched in April 2020: 1,760.
