#### **Gas Curtailment Ordered Following Gas Pipeline Leak**

Gas Industry Co advises that a directive has been issued for the immediate curtailment of gas use by all consumers other than residential customers in the areas north of King Country and in the Bay of Plenty following a serious gas escape from a high pressure pipeline in Taranaki.

The directive, issued by the gas industry Critical Contingency Operator, is intended to manage available gas supplies while the cause of the gas escape is determined and the likely extent of the resulting outage assessed.

The Critical Contingency Operator was advised early this morning of a material gas escape resulting in a loss of pressure on the large Maui pipeline which transports gas north from Taranaki. The escape occurred in the remote White Cliffs area north of New Plymouth.

The pipeline has been isolated and depressurised. A curtailment directive was immediately issued for gas-fired units at the Huntly, Otahuhu and Southdown power stations. This has since been extended to all non-residential consumers, including essential services, on the North Pipeline, Bay of Plenty Pipeline and the Morrinsville lateral pipeline.

An alternative smaller pipeline is being used to maintain limited gas supplies into the affected residential areas, but supply could be at risk without immediate curtailment by commercial and industrial users. Gas retailers are expected to immediately implement their plans to inform their industrial and commercial customers and ensure the curtailment directive is acted on.

While residential customers are not covered by the curtailment directive, they are asked to limit their use of gas as far as possible.

Technical experts are preparing to excavate the section of pipeline to determine the cause of the gas escape. This is expected to take most of today and, until the cause is identified, there can be no estimate of when repairs will be effected.

The Maui Pipeline is owned by Maui Development Limited, with Vector contracted as technical operator. Vector also fulfils the role of Critical Contingency Operator.
