1. Introduction

1.1 In accordance with the standard "Recommendation Request Form" issued by Gas Industry Company Limited (**GIC**), this application by Maui Development Limited (the **Applicant**) includes the following information:

- (a) details of the amendments to the Maui Pipeline Operating Code (**MPOC**) proposed by the Applicant; and
- (b) the reasons for the proposed amendments.
- 1.2 Please also find enclosed with this application a marked up copy of MPOC showing the Applicant's proposed amendments in full.
- 1.3 In making this application, the Applicant has taken into account the MPOC Change Request dated 13 October 2011 (**B2B Change Request**). The B2B Change Request does not have any bearing on the changes proposed in this Application.

2. Shortening of the Approval and Confirmation Times

- 2.1 The current arrangement will remain in place for the Provisional Cycle. This is to allow parties sufficient time to enter all nominations for this cycle.
- 2.2 The Change Provisional and Intra-Day cycles will have the confirmation time reduced to 30 minutes and the approval time reduced to 30 minutes. This change is expected to have the following benefits:
 - (i) Increased opportunities to self-balance;
 - (ii) Reduced financial exposure to balancing costs;
 - (iii) Increased intra-cycle time efficiencies;
 - (iv) Increased time for parties to adjust physical plant after change provisional approvals; and
 - (v) Allows for future investigation of most efficient ID cycles
- 2.3 The Applicant considers the proposed amendments only relate to the clauses of the MPOC required to reduce the confirmation and approval times. The changes proposed are relatively minor and, in the Applicant's opinion, should be uncontroversial. The Applicant considers the changes will not affect parties not subject to the MPOC.
- 2.4 All Shippers and Welded Parties have already been given the opportunity to comment on the changes proposed and no objections were received.
- 2.5 Due to the prior consultation undertaken with all Shippers and Welded Parties and the mechanical nature of changes required the Applicant sees merit in expediting the GIC's change request process to the extent possible.

2.6 There are no substantial costs associated with this change rec	equest.
