Consultation on exemptions

1.1 Exemptions sought

Gas Industry Co has received applications under the Gas (Switching Arrangements) Rules 2008 (Switching Rules) requesting exemptions from the timeframes specified in rules 78.1 and 81.1, which require retailers to respond to gas switching withdrawal notices and switch reading renegotiation notices within two business days. All retailers have an existing exemption in respect of these rules that allows for a five-day response period, and these exemptions will expire on 28 February 2010. All retailers have applied to have the exemption extended until such time that a formal proposal for changing the timeframe in the Switching Rules can be made and considered. Copies of the exemption applications are attached in Appendix A.

Applications note that it generally takes longer than two business days to locate and communicate with affected customer(s) and respond appropriately to gas switching withdrawal and switch reading renegotiation notices. Furthermore, dual fuel (gas and electricity) retailers note that the equivalent timeframes set out in the Electricity Governance Rules (Part E, Schedule E2) are five business days. Aligning the regulatory requirements for these retailers ensures consistency is maintained between consumer expectations as well as retailer business processes across energy products and services.

1.2 Preliminary view

The framework by which transitional exemptions can be assessed and granted is provided in Appendix B. Gas Industry Co's preliminary view of the applications is that:

- granting the exemptions is consistent with the purpose of the Switching Rules (enabling consumers to alternate efficiently and satisfactorily between competing retailers) by providing adequate timeframes for retailers to confirm customer requests to cancel switches or change switch readings;
- in this instance, alignment of the regulatory frameworks across gas and electricity retailing is a reasonable consumer expectation and allows consistency in retailers' business processes across energy products and services;
- granting the exemption is fair to other registry participants, as it would apply equally to all gas retailers; and

• granting the exemptions is a practicable arrangement until such time as a proper review of the Switching Rules can be undertaken.

In addition, the existing exemption has operated successfully since go-live in March 2008 and the feedback from retailers has been that the longer timeframe is necessary for retailers to clarify issues with customers. This point is important as it increases the likelihood that a customer's wishes are given primacy.

1.3 Additional terms and conditions

In the longer term, Gas Industry Co proposes to address this issue via the consideration of potential amendments to the Switching Rules. However, in the interim, Gas Industry Co's preliminary view is that a transitional exemption should be granted, subject to the following terms and conditions:

- retailers must comply with rules 78.1 and 81.1, except that they may respond within five business days instead of two as set out in the Switching Rules; and
- the exemption granted applies from 1 March 2010 to 28 February 2012 (two calendar years).

Do submitters have any comments on the transitional exemption applications or Gas Industry Co's preliminary views of them?

1.4 Invitation to provide submissions

Gas Industry Co invites submissions on the transitional exemptions addressed in this paper. Please note that it is not necessary for exemption applicants to submit in support of their applications, as non-responses from applicants will be deemed to be agreement with granting the exemptions.

A suggested format for submissions is provided in the template in Appendix C. The closing time for submissions is **8:00am on Monday**, **15 February 2010**. Please note that submissions received after this time will not be considered.

Gas Industry Co's preference is to receive submissions in electronic form (PDF format). You may provide your submission by logging in¹ to the Gas Industry Co website (www.gasindustry.co.nz), navigating to the Switching work programme and uploading your document under the consultation tab by clicking on the submissions button.

Gas Industry Co will acknowledge receipt of all submissions electronically. Please contact Ian Dempster if you do not receive electronic acknowledgement of your submission within two business days.

90. Transitional exemption

- **90.1** A **registry participant** may apply in writing to the **industry body** for a transitional exemption from complying with one or more of these **rules**.
- **90.2** A transitional exemption applies for a period set out in the exemption and must set out alternative arrangements for complying with one or more **rules**.
- **90.3** In the application, the **registry participant** must set out the rule or rules from which it seeks an exemption, the detailed reasons for the exemption, the period for which the exemption is applied and the alternative arrangements proposed for compliance with the rules.

90.4 If, after considering the reasons the **industry body** is satisfied that a transitional exemption should be granted, the **industry body** must by notice in writing grant the transitional exemption to the **registry participant** which, in addition to stating the alternative arrangements that will apply, may be subject to such other conditions as the **industry body** thinks fit.

This exemption is sought in agreement with other retailers as the time frame of two days is not practical in all cases to allow consideration to be given to a switch withdrawal notice. Participants have agreed that the time frame, of 5 days, as stipulated in the Electricity Governance Rules – 1 May 2008, Part E Schedule E2 rule 4.3, is a functioning time frame and would like the time frame of 5 days applied as the alternative for this exemption.

<u>Describe</u> how the exemption sought may affect other participants (including service providers) and any costs and benefits to them:

This issue has been discussed with all participants agreeing that the time frame stipulated in this rule was not achievable. This exemption is in support of the Energy Online directive to supply the Gas Industry Company with an industry proposal. We recommend that this exemption be made an

industry exemption.

An exemption is sought from the **two** business day timeframe as it is understood that a current exemption application process is being treated by the industry as a continuation of the current exemption. We further understand that there is potential for the new exemption to apply only to those retailers that apply for the extension of the existing exemption and that if a retailer were not to apply then potentially they will face timelines in line with the rules while other retailers have a timeline in line with a new exemption.

The companies listed above are of the view that the same timeframes in the rules should apply to all retailers whether it be two days as per the rule, five

days as per the current exemption or any other timeframe determined and agreed to through consultation.

Describe how the exemption sought may affect other participants (including service providers) and any costs and benefits to them:

The companies listed above accept that the timeframe to respond to the switching rules can be quite difficult and while making the best endeavors ourselves to comply have not always been successful in regards to the existing timelines.

Removing the exemption for rule 81.10 and 78.1 will increase the breaches occurring in the switching process. Meeting timelines can be difficult due to problems contacting the customer, staff unavailability, timing of sending and receiving notifications and automation of processes and systems can all contribute to these problems.

Quick response times to these notices can be mitigated by the party sending the notice supplying evidence supporting the correct reading or documentation supporting the consumers request to withdraw by email to the other retailer involved and we would expect that this additional process is continued to be supported by other retailers and promoted by the Gas Industry Company as best practice.

Appendix B Transitional exemption framework

Transitional exemptions under the Switching Rules

The Switching Rules provide for Gas Industry Co, as the industry body, to exempt a registry participant from complying with one or more of the Switching Rules subject to certain conditions. A transitional exemption application must apply for a specified period and must also set out alternative arrangements for complying with the rules concerned. If a transitional exemption is granted, notice must be given to the affected registry participant(s). Gas Industry Co will also publish all transitional exemptions granted under the Switching Rules on its website. Rule 90 provides the following:

- 90.1 A registry participant may apply in writing to the industry body for a transitional exemption from complying with one or more of these rules.
- 90.2 A transitional exemption applies for a period set out in the exemption and must set out alternative arrangements for complying with one or more rules.
- 90.3 In the application, the registry participant must set out the rule or rules from which it seeks an exemption, the detailed reasons for the exemption, the period for which the exemption is applied and the alternative arrangements proposed for compliance with the rules.
- 90.4 If, after considering the reasons, the industry body is satisfied that a transitional exemption should be granted, the industry body must by notice in writing grant the transitional exemption to the registry participant which, in addition to stating the alternative arrangements that will apply, may be subject to such other conditions as the industry body thinks fit.

Evaluation criteria

The Switching Rules do not provide any express criteria for consideration prior to the granting of a transitional exemption. Nevertheless, it is desirable for criteria to be established to enable transitional exemption applications to be considered in a consistent manner. The criteria Gas Industry Co has adopted for considering transitional exemption applications under the Switching Rules are based on the criteria set out in the information paper 'Dealing with Exemptions under the Downstream Reconciliation and Switching Rules' and applied as follows:

		An alternative arrangement is defined that is practicable, fair to other registry participants, and consistent with achieving the purpose of the Switching Rules

Other information may be considered when evaluating an exemption application, although such considerations should not override the application of the criteria set out above. Information of this type may include the extent to which:

- there are relevant precedents from prior decisions;
- the underlying issue affects a number of participants rather than just the applicant; and
- granting the exemption affects:
 - o overall industry costs or the ongoing operations of the gas registry;
 - o the compliance regime under the Gas Governance (Compliance) Regulations 2008;
 - o downstream reconciliation processes under the Gas (Downstream Reconciliation) Rules 2008; or
 - o critical contingency management processes under the Gas Governance (Critical Contingency Management) Regulations 2008.

Appendix C Recommended format for submissions

To assist Gas Industry Co in the orderly and efficient consideration of responses, a suggested format for submissions has been prepared. Submitters are also free to include other material on the exemptions in their responses.

Please note that it is not necessary for exemption applicants to submit in support of their applications, as non-responses from applicants will be deemed to be agreement with granting the exemptions.
