Background

1. On 2 February 2011, pursuant to regulations 18(3) and 23 of the Gas Governance (Compliance) Regulations 2008, the market administrator referred alleged breaches by Auckland Gas Company Limited, Nova Gas Limited, Bay of Plenty Energy Limited, Contact Energy Limited, Energy Direct NZ Limited, E-Gas 2000 Limited (now Johnsonville 2000 Limited), E-Gas Limited (now Johnsonville Ltd), Genesis Power Limited, On Gas Limited and Mighty River Power Limited of rule 37.2 Gas (Downstream Reconciliation) Rules 2008 to an investigator, Jason McHerron, for investigation.
2. The alleged breaches referred for investigation involve the failure by the participants allegedly in breach to provide accurate consumption information to the allocation agent for initial allocation, as required by rule 37.2.¹ Under/over-submission of consumption information by a retailer causes positive/negative UFG (unaccounted-for-gas) that affects other retailers at the gas gate. Thus, it is reasonable for retailers who trade at a gas gate where a breach occurred to assume that they may have been affected.

¹ Rule 48.1 provides that an initial allocation is the allocation of gas quantities in accordance with rule 45 in the month immediately after the relevant consumption period.

3. The allocation of gas to each retailer is used as the basis for a number of charges in the gas industry. These include wholesale gas, transmission throughput and overrun charges, and distribution charges. To the extent that balancing costs are on-charged to Vector, the allocation results also form the basis for Vector to recover those costs from the retailers who use its systems, on the basis of retailers' own imbalance positions. Related charges are incentives pool debits charges and peaking charges, which are similarly passed on by Vector to retailers. Together, these charges are referred to as BPP² charges.
4. The majority of charges are washed-up with subsequent allocation stages (interim and final). Accordingly, for these charges, a breach of rule 37.2 does not cause losses to be borne by other participants. The exception is BPP charges, which are not washed-up with subsequent allocation stages. If the BPP charges were washed-up by Vector Transmission (using the interim and final allocation results) then it is likely that the market administrator would have concluded that, apart from the time value of money, no harm relating to the breaches remained. A wash-up of BPP charges would require a change to be made to the Vector Transmission Code, which would have to be initiated by the parties, and it would not address the existing backlog of breaches. Thus, the situation that currently exists is that breaching parties' under/over submission of consumption volumes has led to over/under allocation of volumes to other parties, which in turn has contributed to positive/negative balancing cash-outs, incentives pool debits (IPD) and peaking charges.

The agreed settlement

5. The parties have agreed to accept a simple and cost-effective calculation methodology that has been developed by Gas Industry Co, using a spreadsheet-based algorithm to simulate allocation calculations on a monthly basis. In lieu of BPP wash-ups, invoiced BPP charges are used as the basis for calculating compensation.
6. Gas Industry Co has used the agreed settlement methodology to make calculations of the principal sums payable or claimable by each of the parties. To these sums will be added interest, calculated according to the prevailing 90 day bank bill rate.

The position of E-Gas

7. Two of the alleged breaching parties, E-Gas Ltd and E-Gas 2000 Ltd are in liquidation. E-Gas Ltd has been renamed Johnsonville Ltd and E-Gas 2000 Ltd has been renamed Johnsonville 2000 Ltd. These companies went into liquidation on 18 October 2010 with Jeff Hart (BDO Wellington), Brian Mayo-Smith (BDO Auckland) and Stephen Tubbs (BDO Christchurch) appointed as Liquidators. The Liquidators have agreed to the settlement pursuant to their powers under section 260 and Schedule 6 of the Companies Act 1993. In relation to the E-Gas companies, interest is calculated up to the date of the

commencement of the liquidation, 18 October 2010.³ Amounts determined under the basis of the settlement as being payable by the E-Gas companies will be accepted as claims in the liquidation as pre-liquidation debts of the relevant company or companies as the case may be to be dealt with pari passu with other unsecured pre-liquidation debts of the relevant company.

Payments to be made under the settlement

8. Including interest as at 18 October 2010, the amounts due to be paid to each party by Johnsonville Ltd and Johnsonville 2000 Ltd are as follows, and the parties are entitled to claim as unsecured creditors in the liquidation of those companies accordingly:
 - Energy Direct NZ Ltd \$37,409.77
 - Genesis Power Ltd \$127,158.66
 - Mighty River Power Ltd \$74,089.79
 - On Gas Ltd \$56,443.78
 - Nova/AGCL/BoPE \$65,516.93

9. Contact Energy Limited agrees to pay the parties the following amounts (inclusive of interest), by 20 October 2011:
 - Energy Direct NZ Ltd \$1,983.48
 - Genesis Power Ltd \$6,741.98
 - Mighty River Power Ltd \$3,928.26
 - On Gas Ltd \$2,992.66
 - Nova/AGCL/BoPE \$3,473.72

10. This settlement is subject to the approval of the Rulings Panel pursuant to regulation 34 of the Gas Governance (Compliance) Regulations 2008. If the Rulings Panel approves this settlement, it will be final and binding on the parties, all other participants, and the Rulings Panel, and no further action can be taken in respect of the alleged breaches.

Acceptance of parties to settlement


11. The Allocation Agent notified its acceptance of the terms of settlement in writing to the investigator on 21 September 2011.

12. Auckland Gas Company Limited, Nova Gas Limited and Bay Of Plenty Energy Limited notified their acceptance of the terms of settlement in writing to the investigator on 20 September 2011.
13. Contact Energy Limited notified its acceptance of the terms of settlement in writing to the investigator on 16 September 2011.
14. Energy Direct NZ Limited notified its acceptance of the terms of settlement in writing to the investigator on 21 September 2011.
15. E-Gas Limited (now Johnsonville Limited) and E-Gas 2000 Limited (now Johnsonville 2000 Limited) notified their acceptance of the terms of settlement in writing to the investigator on 16 September 2011. The Liquidators have agreed to the settlement in their personal capacities only for the purpose of receiving the benefit of clauses 5, 6, 11 to 14 (inclusive) and 16 to 18 (inclusive) and the exclusions, limitations, undertakings, covenants and indemnities in their favour contained elsewhere in this record of settlement. The notifying participant and all other participants allegedly in breach and the other parties to the breach notices have acknowledged and agreed that in the negotiation and the completion of the settlement the Liquidators are acting only as agents for and on behalf of the E-Gas Companies and without any personal liability whatsoever. It has been expressly agreed that neither the Liquidators nor their firm, partners, employees, agents, advisers or representatives shall have any personal liability under or in connection with the settlement.
16. Genesis Power Limited notified its acceptance of the terms of settlement in writing to the investigator on 19 September 2011.
17. On Gas Limited notified its acceptance of the terms of settlement in writing to the investigator on 20 September 2011.
18. Mighty River Power Limited notified its acceptance of the terms of settlement in writing to the investigator on 21 September 2011.

Rulings Panel

19. I approve this settlement pursuant to regulation 34 of the Gas Governance (Compliance) Regulations 2008.
