VTC CHANGE REQUEST NOTIFICATION - VTC EXTENSION 2015

Change Request Notification

1 Pursuant to *section 25.4* of the Vector Transmission Code posted on OATIS and effective as at 1 April 2015 (*Code*), Vector hereby notifies Shippers of its wish to amend the Code, for the reason explained in paragraph 2 below, as follows:

1.1 delete section 20.2 of the Code and replace that section with the following:

"Except for *section 2.7 (e)(i)*, the terms and conditions of this Code expire from the end of 30 September 2017."; and

1.2 delete from item 2 of Schedule Seven:

"End Date: [no later than 30 September 2015]"

and replace with

"End Date: [no later than 30 September 2017]".

Reasons for the amendments

2 The amendment is necessary to extend the term of the Code for a further 2 years.

Nature, intended impact and effect of amendments

3 The effect of the Final Change Request will be to extend the term of the Code for 2 years.

Effective date of change request

- 4 Vector wishes the Final Change Request to become effective on the date it is approved in accordance with the Code.

Changes to timeframes

- 5 Vector wishes to ensure that the Change Request is effective before 30 September 2015. In accordance with *section 25.15* of the Code, Vector therefore wishes to obtain the Shippers' agreement to the periods in *sections 25.5* and *25.6* of the Code relating to the Change Request Notification being reduced to 3 Business Days.
- 6 Vector would be grateful if you could give this Change Request your earliest consideration. Shippers should approve the change to timeframes set out in paragraph 5 by an e-mail in reply to the e-mail to which this letter is attached.

General

- 7 Unless the context requires otherwise, all capitalised terms in this Change Request Notification shall have the same meaning given to them in the Code.
