

## MEMORANDUM

TO: GTAC StakeholdersFROM: First GasDATE: 24 July 2018RE: Block 1 Outputs Summary

This memo summarises the materials provided following the GTAC workshops held on 10 to 12 July as recorded in the Draft minutes issued by the GIC on 17 July. It is intended as guide to the materials provided for quick reference. The materials marked as 'issued for consultation' will be open for consultation until 7 August 2018. Submissions should be made to First Gas through the GIC website. The drafting will be further discussed at the Drafting Review Workshops on 4 to 6 September 2018.

It should be noted that Drafting has been issued for comment only once. Where there is overlap between subjects (e.g. Balancing and Target Taranaki Pressure) this has been issued with the most appropriate memo and is noted in the text of the memo. The drafting is based on the GTAC as at 8 December 2017 and only relates to changes discussed workshops already held. There may be further changes based on future workshop discussions (e.g. a no changes have been made to incentive fee charges as this will be discussed in the workshop on 9 August).
