4	Liabilities	4.3.1 First Gas to consider adding First Gas to the definition of an RPO (alongside shippers and interconnected parties) Consideration of adding TSO to definition of RPO alongside shippers and IPs has been discussed and treated in the Liabilities memo and drafting issued 15 August.		
3.5	Confidentiality	First Gas to consider the process for consulting with parties on First Gas's right to disclose confidential information. This issue will be included in the discussion of confidentiality during the workshop on 23 August.
